This has reference to your application dated 21-10-2013 in Tier-I document seeking accreditation of National Board of Accreditation to the UG Engineering programmes offered by **M.S. Ramaiah Institute of Technology, Vidya Soudha, MSR Nagar, MSRIT Post, Bangalore-560054, Karnataka.**

2. An Expert Team conducted on-site evaluation of the programs during 16th to 18th October, 2015. The Report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. In respect of the programmes which have been granted provisional accreditation for 2 years, **M.S. Ramaiah Institute of Technology, Vidya Soudha, MSR Nagar, MSRIT Post, Bangalore-560054, Karnataka** should submit the Self-Assessment Report alongwith a Compliance Report at least after one year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendations of the EEAC will be considered by the Sub-Committee of Academic Advisory Committee of Engineering for a decision.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **M.S. Ramaiah Institute of Technology, Vidya Soudha, MSR Nagar, MSRIT Post, Bangalore-560054, Karnataka** as a whole. As such, the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of programs and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of your Institute.

7. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

8. Copies of Report of Chairman of the Visiting Team and Evaluators' Reports in respect of the above programmes are also enclosed.

9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
