3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. In respect of the programmes which have been granted provisional accreditation for 2 years, M.S. Ramaiah Institute of Technology, Vidya Soudha, MSR Nagar, MSRIT Post, Bangalore-560054, Karnataka should submit the Self-Assessment Report alongwith a Compliance Report at least after one year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendations of the EEAC will be considered by the Sub-Committee of Academic Advisory Committee of Engineering for a decision.

- 5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to M.S. Ramaiah Institute of Technology, Vidya Soudha, MSR Nagar, MSRIT Post, Bangalore-560054, Karnataka as a whole. As such, the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
