This has reference to NBA's letter of even number dated 18.12.2015 through which UG Electrical & Electronics Engineering program offered by your Institution was granted accreditation for 5 years w. e. f. 01-07-2015 in Tier-I by National Board of Accreditation.

2. National Board of Accreditation has decided that in all cases where UG Engineering programs of an Institution were granted accreditation for a period of 5 years in Tier-I/II format, the period of accreditation of these program(s) shall be extended from 5 to 6 years subject to the condition that they meet the Pre-qualifiers for extension of duration of accreditation from 5 to 6 years. The Pre-qualifiers submitted by **M.S. Ramaiah Institute of Technology, Vidya Soudha, MSR Nagar, MSRIT Post, Bangalore- 560054, Karnataka** in respect of the following UG Engineering program for extension of duration of accreditation from 5 to 6 years have been considered.
