This has reference to NBA's letter of even number dated 30-07-2019 under which Master of Computer Applications program offered by your Institution was granted accreditation for 2 years upto 30-06-2021 by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where MCA Program of an Institution was granted accreditation for a period of 2 years, the period of accreditation of the program shall be extended from 2 to 3 years subject to the condition that the program meets the essential parameters of the Pre-Qualifiers.
