This is regarding Pre-qualifiers submitted by **M.S Ramaiah Institute of Technology, Vidyasoudha, M.S. Ramaiah Nagar, MSRIT Post, Bangalore-560054, Karnataka** for the UG Engineering programs in whose case the period of accreditation in Tier I has expired on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in case of all UG Engineering programs which were accredited in Tier I/Tier II in January 2013 document for a period of 3+3 years upto 30/06/2021, the programs will be considered for accreditation for the Academic Year 2021-22 on the basis of programs meeting the pre-qualifiers. The pre-qualifiers submitted by **M.S Ramaiah Institute of Technology, Vidyasoudha, M.S. Ramaiah Nagar, MSRIT Post, Bangalore-560054, Karnataka** in respect of the following UG Engineering programs have been considered. The programs meet all the parameters of pre-qualifiers. Accordingly, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted extension of duration of accreditation for one year. **M.S Ramaiah Institute of Technology, Vidyasoudha, M.S. Ramaiah Nagar, MSRIT Post, Bangalore-560054, Karnataka** is requested to apply afresh for accreditation of the programs in the new SAR Tier I Document. The application may be submitted online on e-NBA portal by 31<sup>st</sup> December, 2021.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **M.S Ramaiah Institute of Technology, Vidyasoudha, M.S. Ramaiah Nagar, MSRIT Post, Bangalore-560054, Karnataka** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
